Initial ALL:

- _____ Water Meter, (Kamstrup, flowIQ2250)
- _____ If the home is lower than the street: you MUST install a sewer pump & backflow preventer.
- _____ All permit fees & sewer & water hook-up fees shall be paid at the time of application & before construction begins.

The following requirements are applicable for all water and sewer connections.

- _____ Applicant/Owner shall ensure foundation is poured within 180 days of date on this form.
- _____ Applicant/Owner is responsible for excavation arrangements and costs.
- _____ Applicant/Owner will install water and sewer service lines to the District’s system. Property owner is responsibility for all lines and equipment as referenced in District’s Rules and Regulations article 6.1.1 water service lines & 6.1.2 sewer service lines.
- _____ Water and sewer lines must be installed as per appendix B-1 Standard Drawings, drawing W-34.
- _____ Upon connection, all service charges are due at the then-current rate. The connection to the District system is perpetual.
- _____ **All service lines SHALL BE inspected by the District BEFORE being buried. If inspection is not made by the District, appropriate fines will be assessed.**
- _____ **Check here if you would like to sign up for automatic payments for service charges.**
